2 CENTS per bushel each pound 50.0 to 51.9

53.0 to 53.9 = 1 cents
52.0 to 52.9 = 2 cents
51.0 to 51.9 = 4 cents
50.0 to 50.9 = 6 cents
Anything below 50.0 – Consult Commodities Manager

MOISTURE:

8.0 CENTS per point starting at 15.6 and breaking at the tenth
Corn above 18.0 moisture is subject to rejection.
